

SIT30122 Certificate III in Tourism

Course Overview

To achieve SIT30122 Certificate III in Tourism, a total of 15 units of competency must be completed, comprising of 4 core units and 11 elective units. The trainer will assist in selecting the most appropriate units to study based on the learner's desired outcome. This is a self paced course that will take between 6 -18 months depending on the learner and their individual circumstances (up to 24 months if undertaken as a traineeship). Training is available in a variety of locations and can vary depending on the delivery mode selected. Our RAPAD Skilling trainers travel to the seven RAPAD council regions of Longreach, Winton, Barcaldine, Blackall-Tambo, Boulia, Diamantina, Barcoo and beyond.

Credit Transfer

Recognition of Prior Learning (RPL) is conducted for experienced workers seeking to have their current skills and knowledge acknowledged. The RPL process requires the collection of evidence documents to support the determined outcome.

Award
